1. From your Soroptimist and personal activities share examples of how you have specifically supported the Soroptimist mission both in service and financially.

My Soroptimist passion has always been our programs, and I have a special affection for our Soroptimist Live Your Dream Awards program. As my club's chair for many years, I have developed and maintained strong mentoring relationships with many of our award recipients. In 2016, I worked in partnership with Susan "Sam" Buchenau of SI Valley de Oro, to create the San Diego County Live Your Dream Collaborative which brought 12 clubs in San Diego County together to identify and secure more LYD applications through building relationships with our community colleges.

The creation of this collaborative arose because clubs in San Diego County exist in close proximity. As a result, the clubs were in competition with one another to secure applications, with the result that the 'first club in the door' received multiple applications while the remainder were left with few or none. This also diluted our public awareness, as the college advisors had no idea of who Soroptimist was, so the applications just went to the financial aid office where no one really paid attention to it. In order to increase our impact and reach more women with the award, we had to figure out a better way to be equitable with applications AND have the colleges understand who we were. We also needed to communicate that we could offer something more powerful than a standard scholarship opportunity. We discovered a statewide program within each community college in California where the eligibility of students in the CARE program exactly matches our LYD eligibility and this discovery was a partnership made in heaven. Soroptimist and our Live Your Dream Award is now well known in our 10 countywide community colleges, and they now contact us at the beginning of the school year to schedule application workshops for CARE students. Because of our success in San Diego County, our collaborative approach was mirrored in Orange and Los Angeles County within the Desert Coast Region. In the last 5 years we have increased the number of awards given by 45% and working collaboratively have given 330 Live Your Dream Awards.

I have been an active and impactful retired governor, or as we're called in Desert Coast, a STAR (Supporter, Teacher, Advocate and Resource). I've been a regular and inspirational trainer and workshop presenter at District Meetings, Leadership Trainings and Spring Conferences.

I am also a devoted supporter of SIA and have consistently given to the Laurel Society since the inception of Monthly Giving. I am a vocal supporter at my club and beyond on the importance of supporting our Federation with individual and Club Giving. I also was a strong advocate for SI San Diego's support for the Dream Big Campaign, because I believe strongly in the necessity of investing in our own future as an organization as well as in the women and girls we serve.

1. From your Soroptimist and personal activities share examples of how you have specifically supported the Soroptimist mission both in service and financially.

From my joining in 2005, my heart and my passion has been in total alignment with our mission and that is to improve the lives of women and girls through access to education, training and mentorship leading to economic empowerment as you can see by my involvement, creativity and focus.

Every activity I do, including the other organizations I am affiliated with has to do with making a difference in the lives of others, particularly women and their families and girls. I am a cheerleader when they need someone to cheer them on and a pair of ears when they need someone to "just listen".

I believe I was born with service to others in my DNA. I didn't like candy as a child so when I was 8 years old, my mother gave me a can, and I trick or treated for UNICEF. I also helped collect donations for the Mothers March of Dimes and the United Way while still in grade school.

Fast forward to the 90's. I spent 9 years as a volunteer for Working Wardrobes and was on the Planning Committee for most of those years for Working Wardrobes Day of Self-Esteem for Women and later for men, as well. In addition to being on the Planning Committee for the Days of Self-Esteem, I was a Success Coach for 6 years. As a Success Coach, I led job readiness training for women parolees and formerly homeless women and men. The job readiness training included conducting a True Colors workshop, discussing transferable skills, SMART goals, resume writing and interview skills.

Speaking of True Colors, I conducted a workshop for 95 Soroptimists at a Desert Coast Region Leadership Academy.

When I first joined Soroptimist, I still worked full time and traveled extensively for my job but I still joined 2 committees: one focused on the Huntington Beach Duck-A-Thon, which raised money for the community clinic and the other was our Dolly Wakeham Memorial Grant Program, where we adopted a single mom who was going to school and helped her by providing essential non-food items, assistance for school-related expenses, like college admission fees and more. I quickly became the Chair of the Dolly Wakeham committee which then morphed into being the chair for Live Your Dream and later, the Service Director for our club.

As the District II Director, I visited all of the clubs at least twice during my biennium, ensuring that every club and every member felt important and heard.

More recently, I have done Big Goal Accelerator Projects presentations for several clubs.

In 2014, the City of Huntington Beach Chamber of Commerce awarded me the International Athena Award, given annually to a professional female leader who has demonstrated significant achievements in business, community service, and the professional advancement of women.

From a financial perspective, I am a member of the Laurel Society and a Stargazer and a member of Laurel Legacy. I participate in all of my club's fundraisers plus those of other clubs, too.

I firmly believe in working for the good of the whole. I sold enterprise software for 20 years to the federal government, municipal governments and Fortune 100 companies. I led large sales teams which included

executives in the companies I worked for. I believe that everyone has a voice and should be allowed to express their opinions but, I also believe that when you are on a team of any kind, that you leave your personal agendas and biases at the door and focus on what is good for the whole. We are a multi-country, multi-cultural organization and if we don't work together as one, we won't survive.

3. What is there specifically in your background, training, education, experience, and interests which qualify you to serve as a member of the SIA Board of Directors?

I believe my background in leading teams as well as being a team member, my training in consensus management, working with diverse teams, my education both formal and in business, my experience as a team leader and a business owner with employees and my interest in helping women and girls see their true potential and feel worthy of "going for it" despite the obstacles they have to overcome along the way and my undying passion for our mission qualify me to serve as an active and dedicated member of the SIA Board of Directors.

I succeeded in business because I did my homework and knew how the company operated, what their vision and mission was, how they stacked up against their competitors and because I was good at analyzing and adept at presenting concepts which led to improving a company's bottom line.

I feel blessed to remain in contact with many of the women our club has helped over the years – long after we have helped them, or they have been a Live Your Dream (formerly Women's Opportunity Award) honoree. I was instrumental in helping a former woman who attended our Day of Empowerment become the Desert Coast Region's webmaster. She is also a member of our club now and a woman I am proud to call friend.

4. How will you leverage your skills and experiences to help SIA achieve our 2021-2031 Big Goal of Investing in the dreams of half a million women and girls through access to education?

I believe my skills in sales, managing diverse teams and being a business owner will help SIA achieve its Big Goal. I believe we have a long way to go to realizing that dream, and I would like to be part of the team that helps get us there. I am comfortable dealing with C-level executives and giving presentations to small and large audiences.

I am a big picture person who thinks outside the box. I look at how something is and imagine how it could be and how I can contribute to making it better. At one point during my software career, I sold a shop floor scheduling system based on simulation technology. Since I had been selling into major corporations, I knew that there was more funds for products that helped in planning vs scheduling and sold the first multi-million dollar deal to a major aerospace company to their planning department. I was the number 1 salesperson in the company that year. Another time, I sold a shop floor control software that had only been sold to semiconductor companies but, I saw a need for companies who manufactured medical devices because their challenges were the same. I sold the first multi-million dollar deal to the second largest manufacturer of pacemakers. I was the number 2 salesperson in the company that year. It is for those reasons, plus my passion for our mission, that makes me want to serve on SIA's Board of Directors.
