1. From your Soroptimist and personal activities share examples of how you have specifically supported the Soroptimist mission both in service and financially.

I first joined Soroptimist in 2006 in Laramie, Wyoming. During my time at Soroptimist International of Laramie I served as Recording Secretary in my first full year as a member. I served on the Women's Opportunity Award committee and helped to put on a casino night fundraising event. When I moved to Fargo, North Dakota, one of the first things I did was rejoin Soroptimist. As a member of the Soroptimist International of Fargo club, I served as Treasurer, Vice President and President. I served as the Dream It, Be It chair and worked with local partners to host a day long conference for girls. I was also able to use my computer skills to design our ticket for the club's Garden Tour fundraising event. I served on the bylaws committee during the merge of the Fargo and Moorhead clubs.

In 2016, I became a monthly donor. I am now at the Ambassador level with my donated funds going to Dream It, Be It, the Dream Big campaign and I also donate specifically to the general fund to support administrative costs. For my local club, I donate each year during our community's Giving Hearts Day which raises funds for our Live Your Dream awards.

As Soroptimist is my charity of choice and truly a passion, I serve as Secretary of my club, Program & Technology Chair of Peaks to Plains Region and Chair of the Big Rocks, the past Governors of Peaks to Plains Region. I have also taken on the role of US Country Working Group Leader for the Federation Fundraising Council. Soroptimist is where I choose to spend my free time. It is where I give my time, my talents and my treasures.

In my line of work, I am what we call a fact-finder. Which means, I like to gather information and talk to people to understand all sides and outcomes. One of the most important pieces of this type of decision-maker is to communicate the reasoning why. When I was Governor of North Central Region, we were faced with the tough decision of needing to merge with another Region. The bylaws team did a lot of work to gain collaboration and buy-in but there were some decisions that had to be made by the group and just implemented. Having served on the North Central Region board and Peaks to Plains board, I have experienced times when there were decisions that needed to be made for the overall Region that would not always be popular with clubs. Items like increases in dues, or fees for events all have to be looked at from the lens of what is best for the Region. Once a decision is made, it is then critical to communicate the reasoning behind the decision which I have found has created more buy-in and understanding of decisions that are made.

3. What is there specifically in your background, training, education, experience, and interests which qualify you to serve as a member of the SIA Board of Directors?

I am truly passionate about the mission of Soroptimist. I choose to spend my free time with Soroptimist at most levels, club, region and federation. I look forward to continuing my knowledge of Soroptimist by serving on the board as well as being the first board member from the newly formed Peaks to Plains region.

For the first 16 years of my working life, I worked for non-profit organizations. As an employee of this type of organization, I understand how important the members are to guiding the organization. As the staff member for the committee organizing education offerings, I would implement the needs of the members by finding speakers and scheduling events. The other part of my job was to serve as the staff member for the charitable foundation. Through that, I organized fundraising events, the charitable remodel of a home, and volunteers for a camp for

high school students. Those tasks taught me how to delegate and how to rely on people with skills in specific areas. I found collaborating with people to be very rewarding.

As a member of Soroptimist, I am on the receiving end of all the amazing work our wonderful staff do behind the scenes to support the vital work being done by members in their local communities.

My work experience along with my time as Soroptimist member will help me to serve as an SIA Board member. I believe my history will be a foundation of knowledge to continue supporting our mission to invest in the dreams of 500,000 women and girls by 2031.

My time implementing fundraising strategies while also managing a committee will serve the SIA Board of directors in continuing to find ways to raise funds to invest in ourselves and our programs.

We must continue to support SIA headquarters staff and all the work they do to implement the Live Your Dream portal and program, the Dream It Be It curriculum and Big Goal Accelerator Project to name a few. These projects help clubs work to complete our mission on a local level. My experience working for a non-profit and as a member will serve me well in making the best decisions for our organization.

1. From your Soroptimist and personal activities share examples of how you have specifically supported the Soroptimist mission both in service and financially.

I have been a member of the Laurel Society since 2002 and am currently at the Ambassador level on my way to the inner circle. I have been a member of the stargazers monthly giving for over 10 years. I am committed to continuing with my financial support through monetary sponsorships of our district and regions meetings as well as through the stargazers.

I have been able to charter new club in my area using social media and networking. We started in June with a Facebook post expressing a desire to charter a club for the local communities and had great responses. By September we had thirteen members signed up to officially charter a club. We have been discussing ways as a new club to get our name out and further support the mission of supporting the women and girls in Central Oregon. We have members from a wide variety of professions that we can partner with to promote education and economic empowerment for the women. This includes working with law enforcement, social service agencies, and the community college to promote the Live Your Dream award program. We have five surrounding communities that do not have a Soroptimist club that we will reach out to and share out Dream It Be it program to see if we can facilitate the program. We are in the initial stages of planning a gala event to raise awareness of Soroptimist and raise fund to further support or mission. We are working on a way to incorporate this event to support the Beig Goal accelerator project.

In my everyday life I promote the Live Your Dream with coworkers who aspire to advance their education by attending nursing school. I live by the values of Soroptimist and treat women with the respect and dignity they deserve regardless of their presentation at the hospital. This includes the houseless population we serve, those with addiction issues, victims of abuse as well as our elderly populations experiencing memory issues. I sit with them and let them share and heal offering comfort and resources as appropriate.

When I went out on that stage and welcomed the convention body of eight hundred Soroptimist representing twenty-one countries to the convention, I was inspired. At that moment I knew I needed to do more. I need to serve in a higher capacity, to make a difference in our world and for the rights of women globally. Having eight hundred women cheer me on for my opening speech made me think how amazing that would be to cheer on a woman in need that feels her self-worth is so low and that no one would believe in her. I want to be that woman. I want to help make a difference and let women and girls know they are worthy of love and respect. They deserve a chance in life, and the members of Soroptimist believe in them and are here to provide support so they can achieve their dream of education or economic empowerment. I believe as a member of the SIA Board of Directors, I can help make that difference. I can be a part of the decisions that move our organization forward to serve women and girls globally and reach out Big Goal. I have the skills and knowledge as well as life experience that will guide me to make the right decisions for our organization. Throughout my years as a Soroptimist member, I have served on the Live Your Dream Award®, Dream It, Be It®, and UpliftHER program committees, either in a leadership role or supporting other club members. I am an advocate for all members to embrace our mission-focused programs. I am proud that SI Cascadia Online is focused on the Dream Programs and completed our first Big Goal Accelerator and UpliftHER project in May. As Northwestern Region Governor, I initiated a Big Goal Accelerator Project at our 2024 region conference, which helped incarcerated women earn college degrees.

Financially, I have been a member of the Laurel Society and Laurel Legacy since 2000, and a Stargazer since the program's inception in 2019. I was also an early donor to the Dream Big Campaign. From 2008 to 2010, I served as the District 1 Fundraising Representative, assisting the Northwestern Region in increasing membership in both the Laurel Society and Laurel Legacy. I have contributed at the club level by organizing and supporting fundraising initiatives to further our programs. In 2023, as the Northwestern Region Governor, I helped lead a region conference fundraising event for the Dream Big Campaign, successfully raising \$12,200.

Additionally, I participated in the annual BoardSource Leadership forum for ten years, deepening my understanding of effective nonprofit governance and purpose-driven leadership. Through these opportunities, I have sharpened my skills as a consensus builder, a respectful communicator, and a big-picture thinker.

I bring a dual perspective of governance from both staff and board member roles, with 22 years of leadership experience as the CEO/executive director of nonprofit organizations and extensive volunteer service on community and regional boards, including three years as president of the Washington Museum Association.
